Liaoyuan currently has over 50,000 registered personal and institutional members, and has hosted or published over 2,200 startup events in North America with an exposure to over 400,000 Chinese students and local entrepreneurs. Liaoyuan is helping dozens of top VC institutes from U.S. and China by providing investment leads and talent acquisition service. Liaoyuan is headquartered in Boston and has an office in Shanghai. Liaoyuan has completed two rounds of funding of over 1.8 million USD and is currently seeking Series A funding.
